We're excited to bring back the 15th Annual Festival at Liberty Station's Ingram Plaza again this year. It's a gorgeous flat, grassy park just a stone's throw from the bay. The historic home of San Diego's Naval Training Center has been transformed in recent years—it has become a creative hub for all things artistic in San Diego.

ArtWalk @ Liberty Station is a **free** two-day event and is open to the public.

The event features hundreds of visual artists, musical performances, and a kids' area. ArtWalk's mission is to promote art, education and technology in the diverse cultural life of San Diego. Attendees include art enthusiasts and buyers, fellow artists, families and casual visitors. Additionally, the venue offers plenty of free parking for exhibitors and attendees.

The ArtWalk management team will review all food vendors who apply and they will be accepted based on type of food item sold, display tent and if they have participated with us in the past. All vendors will be notified in late June if they have been accepted or not.

Food vendors will only be allowed one location per company (i.e. cannot have multiple locations for the same vendor). One location can be a 10' x 10' space or a 10' x 20' space, but not (2) 10' x 10' spaces separated.

If you are a first-time applicant to ArtWalk @ Liberty Station, please include a photo of your food booth, menu items, and pricing with your application.

Keep in mind that there is no electricity available at ArtWalk. Vendors are to provide "quiet generators" for any power requirements and all food vendors must have current and up to date San Diego County Health Permits, business licenses and Certificates of Insurance.

***Copies of these permits are required with your application** or your application will not be accepted.

*All Food Vendors will be expected to adhere to current COVID-19 directives.
